Welcome to another school year! Please take the time to read over this handbook and review it with your child.

Please note these protocols established in 2020 will remain in effect for the upcoming school year.

- If you would like to schedule a meeting with a teacher, it must be planned ahead. No unscheduled meetings will occur during the school day.
- Parent volunteering in the classroom will not be allowed
- Lunch in the cafeteria is not available to guests. Therefore parents will not be able to eat with their children during the school day.
- For safety and security of all students, there will be no entering the building for student pickups and drop off. Parents will need to drop off and pick up their children outside of the building.

Attendance is critical to your child's academic success. Unless your child is ill, please do all that you can do to make sure that your child attends every day. If for any reason your child becomes reluctant to come to school, please communicate and we will work together to solve any problems.

Whether it is assigned or not, reading is something that your child could do at home on a daily basis. We strongly encourage any type of reading, including being read to, as the academic benefits are too many to mention. If you are interested in practicing math at home or reading with your child, your child's teacher will be glad to support you with ideas and resources.

General Elementary School Information

Communication:

The elementary office is open every school day from 7:30-4:00.

Teachers have phones in their classrooms with voice mail. Parents are encouraged to leave a voicemail message with the teacher so the teacher can return the call. Teachers and the office can also be reached via e-mail. Email addresses are teacher first name last initial @lucksd.k12.wi.us.

Health and Safety:

Mandated reporting:

All district employees are mandated reporters for any reasonable suspicion that a student has been physically abused, emotionally abused, or neglected. Staff must immediately file a report with the Polk County social service agency. The agency will then investigate and follow up on such reports. The school cooperates fully with all investigations.

Access to school facilities:

The district takes every possible precaution to ensure that our schools are safe for students, staff, and visitors. Visitors, substitute teachers, contractors, and vendors (this includes all parents) must enter through the high school office and register. They will then get an identification badge. A photo ID may be requested.

- · All visitors and parents must sign in
- Temporary identification will be issued
- Parents picking up students at the elementary school must follow the same procedure.
- Elementary parents need to check out their child in the main office
- · Parents SHOULD NOT go down to the classroom or to the elementary school to pick up a child
- The office staff will call the child down to the office for parent pick up

Health Care Plans:

Chronic health problems such as asthma, allergies, diabetes may necessitate the development of a care plan to address student needs in the school setting. The Polk County school nurse serves as our health liaison and will set up plans if necessary.

Health services:

First aid will be provided for sudden illness or accidental injury occurring during school hours. These services do not provide the type of medical care that parents would normally expect from a family doctor. Parents will be notified when it is the opinion of the school office that an injury or illness requires further attention. Parents WILL BE contacted if a child is running a temperature. The child will need to be picked up from school. Students must be FEVER FREE for 24 hours before returning to school. If your child is ill and is staying home from school, please call the school office so the teacher can be notified of your child's absence.

Head lice:

It is the practice of the district to send any students home from school that show evidence of lice or nits and require them to be nit free before returning to school.

Life threatening allergies:

The district has procedures for addressing the needs of students who have life threatening allergies including food allergies, bee stings, and latex allergies.

Medication:

All prescription medication must be checked in at the Elementary School office. School personnel shall only dispense those medications necessary to maintain the child in school or that must be taken during school hours. School personnel shall not dispense any prescription medication to students without written authorization from a licensed prescriber nor dispense non prescription medication without written authorization from a parent.

<u>Safety:</u>

Luck School is committed to ensuring that each child attends a school in a safe, secure environment. The district continually reviews safety procedures. If parents observe, or their child reports anything suspicious, in or around the school, parents should inform the principal.

The School District of Luck does not discriminate on the basis of sex in the education program or activity that it operates, and that the school district is required by Title IX and Part 106 of Title 34 of the Code of Federal Regulations not to discriminate in such a manner. Student and Parent Particulars:

Attendance/Call-in procedure:

When a child is absent or will be tardy, the parent should call the school office within two hours of the start of the school day. Students should bring a note from their parent or guardian upon their return to school.

<u>Absences – Pre-Arranged:</u>

Upon written request from a parent, the principal may approve pre-arranged absences. Approval will be granted when the situation is of benefit to the student.

- Teachers are NOT required to give homework in advance of a student vacation
- Teachers may provide some work, but reading every day and keeping a journal is requested
- Upon your child's return, they will be given an appropriate amount of time as determined by the teacher in order to complete necessary assignments and assessment.

Birthdays:

Birthday parties are NOT held at school because they take away from instructional time; however, your child's special day is important. Your child's name will be read over the loudspeaker during morning announcements. Please notify the teacher in advance before sending a treat. Individually wrapped treats are easiest to distribute in the classroom. Please do not bring in cakes, sheet cakes, candies or drinks. Please check with the teacher regarding the number of students in the classroom.

Cafeteria visits:

The cafeteria is closed to non-students and staff during the school day, therefore parents, friends, and relatives are not allowed to eat during school hours.

Cell phones:

Cell phones may be brought to school but must remain in the student's backpack or locker during regular school hours. The phone must be turned off during this period of time as well.

Discipline/Behavior:

We expect all students to embrace PBIS (Positive Behavior Intervention System) which we have now been implementing for a number of years here at Luck Schools. Parents are notified of any incident that results in a referral to the office and results in disciplinary action. For an explanation of rules and consequences, please look to that section in this handbook.

Field trips:

Field trips are a part of a child's educational experience at Luck School. Parent attendance on field trips will be based on the supervision needs for the individual trip. Due to insurance and supervisory reasons, neither siblings nor children from outside the classroom are permitted to attend field trips. Your child's teacher will provide you with further information throughout the year regarding the field trips and guidelines for each trip. Field trips are a privilege; student participation is not guaranteed.

Schoolwork Policy

Students will receive instruction and facilitated activities for each subject to prepare students to complete individual assignments. Schoolwork is to be taken seriously. Schoolwork is a way of showing the classroom teacher students' understanding of the subject matter being taught. When students do not complete assignments, it is very difficult for teachers to ascertain whether students have a good understanding of the lesson.

There is schoolwork every day. If a student does not complete the schoolwork during the time given in class, it then becomes homework.

Reading at home (by your child or to your child) is expected every day.

Hot Lunch Program:

Luck School offers a daily hot breakfast and hot lunch program. Menus are sent home monthly. Payment is made through a lunch account debit system. Each child is assigned a number for their account. Students have the option of purchasing a lunch or bringing a lunch from home. Milk may be purchased for students who choose to bring a lunch from home. Applications for free and reduced lunch are available through the school office. Lunch money payments can be made online or by sending money to school

Money brought to school:

Any money brought to school should be brought in an envelope with the child's name, teacher name and the purpose of the money written on the envelope. Checks should be made out to Luck School unless otherwise indicated.

Personal Belongings-Lost and found:

Students occasionally misplace things. All articles of clothing and school supplies should be marked with the students' name. Students are expected to check the "Lost and Found" periodically for missing items. Students should not bring valuables to school. The school is NOT responsible for lost or stolen personal items.

Promotion/Retention:

Promotion is the action that advances a student from one grade to the next on the basis of demonstrated academic achievement.

Retention is the action that provides the student the opportunity to gain or reinforce learning based on an adopted course of study and objectives by being reassigned to the same grade level. The principal has the authority to promote or retain students. Parents are officially notified during the school year when there are concerns regarding the educational process of their child and that a conference needs to be scheduled. At this conference the teacher will inform the parents the reason why their child is being considered for retention and discuss ways to help the child. High expectations from parents encourage academic success. Encouraging students to attend school, complete assignments, and take responsibility to learn will, in most cases, ensure success. The final decision will not be made until the end of the school year. The decision to retain students is never easy and many factors are taken into consideration. Among these are:

- Attendance
- Social maturity
- Report card grades/progress
- Grade level expectations
- Work habits/daily achievement

Reporting student progress:

Report cards: Report cards are issued two times a year (end of semesters) in grades K-5, and progress reports will be handed out at the end of quarter 1 and quarter 3. Luck Elementary uses narrative grading based on standards and benchmarks.

Parent /Teacher conferences are held two times each year. Parent participation in the conferences is expected as you will gain valuable information about your child at school.

Success steps for parents:

It is important to develop a positive home learning climate to help children succeed. Parent can accomplish this by:

- Encouraging and expecting high performance from their children for school work, household duties and other responsibilities.
- Showing interest in what their children do each day in the classroom by asking specific questions.
- Providing proper conditions for home study, including definite study time in a quiet, non-distracting place.
- Limiting the amount of time spent watching the television, using the computer or gaming devices.

<u>Supplies:</u>

Luck School District will be providing your child with all appropriate school materials. This includes all supplies needed in the classroom and a school-issued Chromebook. This excludes backpacks and clothing for outdoor activities/recess.

<u>Textbooks:</u>

Each student will be given textbooks. Students are responsible for the books and must pay for them if they are stolen or lost.

<u>Toys:</u>

Toys, electronic equipment, pagers, trading cards and memorabilia, pets and any other items that may cause a distraction or disruption to the classroom or school environment should not be brought to school unless it has been requested by a teacher as part of a classroom activity. Anything brought without teacher request shall be confiscated. Parents may pick up the item(s) up in the office.

Video Taping:

Due to student safety and copyright considerations parents and students must refrain from posting video images from any school performance or activity on the internet.

<u>Visitors:</u>

If you would like to schedule a meeting with a teacher, it must be planned ahead. No unscheduled meetings will occur during the school day. Teachers will be available by email, phone, video conference and in person for meetings.

Support programs and services:

Positive Behavior Intervention Systems:

PBIS is a proactive approach to establishing positive behavioral supports and social culture needed for all students in a school to achieve social, emotional, and academic success. The focus of PBIS is to be proactive by teaching expected behaviors and social skills, and applying data-based decision making to discipline, and social emotional learning at our school. PBIS promotes family and community involvement at all levels of implementation.

Response to Intervention(RtI):

Changes in the Federal and state laws have directed schools to focus more on helping all children learn by addressing problems earlier within the general education setting. These new laws emphasize the importance of providing high-quality scientifically-based, data driven instruction and interventions, and holding schools accountable for the adequate yearly progress of students. This new process of providing interventions to students who are at risk for academic or behavioral problems is called Response to Intervention (RtI).

RtI is a framework that:

- Is a positive proactive approach to educating each and every child
- Provides high-quality, research based instruction and intervention based on individual student need
- Uses assessment data to monitor student progress frequently in order to make decisions about how and what to teach children who are not making sufficient progress academically, social-emotionally, or behaviorally

Educators and staff are able to give students help promptly within the general education setting as soon as a problem is identified through assessment and data analysis. If a student is not benefitting from an

intervention or improving at a sufficient rate, staff can modify the intervention according to what the assessments show is needed.

Special Education services:

Luck School provides a continuum of special education programs to meet the needs of students with identified disabilities between the ages of 3-21. Services available in the district include smaller classes for specialized instruction, resource services, speech and language services, occupational therapy, and physical therapy. The district also employs school guidance counselors and a psychologist to complete evaluations, provide teacher consultation, and provide direct service to students. Parents will always be contacted for consent before any services are initiated or there is a recommendation for evaluation. When a student is determined eligible for special education, and Individualized Education Plan (IEP) is written by the IEP team. The team includes parents, regular education classroom teacher, administrator, special education teacher, speech pathologist, guidance counselor, and any other person directly involved with the student. Continued special education eligibility is reassessed at least once every three years.

Title 1 Services:

- Once removed from the classroom, the student will be allowed time to calm down

PROHIBITED SUBSTANCES

Use, possession, or distribution of illegal drugs, including but not limited to marijuana, LSD, Cocaine, barbiturates, ecstasy, and other mind altering drugs. Other prohibited substances include prescription and over-the-counter medications, look -alike drugs, tobacco, alcohol or any other items that can endanger the health and safety of other students are prohibited on school property. Any violations will be referred to the local police and/or Polk County Sheriff's Department.

MISUSE OF TECHNOLOGY
